



ANNOUNCEMENT

Approved by agreement of the *Junta de Govern Local* dated April 10, 2019, the regulatory bases and the regulatory technical requirements for the International Project Competition for the new urban centrality resulting from the undergrounding of the railway tracks in Sant Feliu de Llobregat, and its tender.

1. ADJUDICATING ENTITY.

2. OBJECT OF THE CONTRACT.

Object Description: International Project tender for the new urban centrality resulting from the undergrounding of the railway tracks in Sant Feliu de Llobregat.
