Justification of the need and suitability of the recruitment of verification process and authorization of access to the infrastructure of recharging electric vehicles managed by Barcelona de Municipal Services, SA

In accordance with article 28 of Law 9/2017, of November 8, on Contracts of Public Sector (hereinafter, LCSP), this report is issued for the purposes of justifying the nature and extent of the needs that are intended to be covered through the present agreement, as well as the suitability of its object and content to satisfy them.

First.- Needs to be met: The needs to be met through this agreement consist of defining the necessary requirements as well as the technical procedure that enables different electromobility service providers (EMSPs) to operate through the electric vehicle charging network managed by Barcelona de Serveis Municipal

Second.- Object of the procedure: The object of this document is to define the requirements necessary as well as the technical procedure that enables different with Suppliers of Electromobility services (EMSP) operate through the electric charging network of vehicles managed by Barcelona Municipal Services. Through the monitoring of requirements, the procedure will be conducted that will allow the interested parties to operate with the purpose that its users can recharge the batteries of their vehicles electricity in the network of charging points managed by B:SM.

Third.- Term of execution of the contract: The duration of the agreement, to cover the needs to be met, is set at ONE (1) YEAR, with the possibility of four (4) extensions of an annual nature.

Fourth.- Suitability of the object and content of the agreement: Through this agreement is will satisfy the needs specified in the first point of this memorandum, in accordance with the technical justification attached to it.

It is considered that through this agreement they will be satisfied directly, clearly and proportional to the needs established in the first point of this report.

Attached to the file is the reasoned report of the service that promotes the hiring, everything setting out the need, suitability and characteristics of the agreement, as well as its value estimate and justification thereof.

Fifth.- Justification of the procedure used for awarding the agreement: The this agreement will be awarded through a procedure not subject to the LCSP, being necessary the preparation of the specifications of particular clauses and technical prescriptions that govern the corresponding tender.
