- c) Division by lots and number: No. It's considered a single lot because the product will be sent to our company's headquarters because this is where we will store it and use it when necessary in each of the 4 municipalities where we work (Jamba, Chicomba, Cuvelai, Cahama). These products are only used by medical students working with us. For good cost control, they are supplied when there is a medical need to check for anaemia and malaria respectively.

Therefore, the division of the subcontract into lots is not considered advisable, since the award to a single bidder will facilitate the proper execution of the service from a technical and organizational point of view. The division into lots would make the execution of the contract excessively difficult and onerous. The need to coordinate the different contractors for the various lots could seriously risk undermining the proper execution of the contract.
