
On June 10<sup>th</sup> 2024, at 10:30h and in private session, in accordance with the report of the Directorate General of Public Procurement of the Generalitat de Catalunya dated 12<sup>th</sup> April 2018, the Contracting Committee is constituted with the following attendees:

## **Session development:**

First. - The objective of this trade document is the contracting of the supply medical devices and tests to the project "Mother and child interventions for chronic undernutrition in Angola. A community cluster and cost-effectiveness trial" (MUCCUA STUDY) as part of the project "Operative Research Against Chronic Child Malnutrition in Angola" (CRESCER PROJECT)- FED/2020/418-106 from Fundació Hospital Universitari Vall Hebron - Institut de Recerca (VHIR), procurement procedure that was published in the Contracting Party's Profile dated on June 24th of 2024.

Second. - The President of the Contract Awarding Committee orders the opening of the unique Envelope No. 1 "Administrative Documentation" and the Secretary verifies and certifies the contents of the documentation submitted by the bidders.







**Three.** - Hereafter, the documents provided by the bidding companies are qualified, within the established term and in the manner, in accordance with the provisions of the Specific Administrative Bidding Conditions that governs this contracting procedure.

**Fourth.-** After reviewing the administrative documentation contained in Unique Envelope, it hasn't been detected the existence of some amendable defects in the documentation provided by the bidder.

\*If after having applied the automatic formula to a submitted offer, the resulting value is negative, zero (0) points will be assigned directly from the economic part.  $P_v = 0$ .

## AUTOMATIC EVALUATION CRITERIA.....(up to 40 points)

The automatic evaluation criteria will be carried out proportionally based on the offer that presents a greater reduction, using the following formula:

$$P(N) = M \times (2 - N/B)$$

P(N): Score of offer N

M: Maximum possible score

B: Best offer submitted

N: Offer to be valued

The bidders will provide a responsible statement regarding the evaluation criteria of this section and before the award they will request the documentation that proves it.


