

SERVICES CONTRACT

On the one hand, Ms. Judit Carrera Escudé, General Director of the **CENTRE DE CULTURA CONTEMPORÀNIA DE BARCELONA (CCCB)**, with registered office at Calle Montalegre, No. 5, Barcelona (08001) and NIF P-5800017-E, on behalf of and representing the same, in the use of the powers attributed to her by virtue of the Statutes of this Consortium.

And on the other hand, Mrs. **TSITSI DANGAREMBGA**, with Zimbabwean passport [REDACTED] acting on her own behalf, with registered office in [REDACTED].

ADMINISTRATIVE BACKGROUND

First.- The contracting file, processed according to the ordinary proceeding, through a negotiated procedure without publicity, of the advisory and curatorship service within the framework of the 1st International Residences Program, and authorization for the temporary use of the appartement located at Av Diagonal No. 365 in Barcelona (Exp . CCCB/2024/0027306), was approved by Decree of the General Director of this entity.

Second.- The maximum expenditure arising from this contract for an amount of €19,500.00, excluding VAT, will be charged to budget application 1.33412.22712 of the CCCB expenditure budgets for the year 2025.

In view of this background, the parties mutually recognize their competence and capacity to formalize this contract, in accordance with the following:

CONTRACT CLAUSES

First.- The General Director of the CCCB, formalizes in favor of Mrs. Tsi Tsi Dangarembga with Zimbabwean passport [REDACTED] this contract relating to the advisory and curatorship service within the framework of the 1st International Residences Program, and authorization for the temporary use of the dwelling located at Av Diagonal No. 365 in Barcelona, subject to the technical specifications and other attached documentation, contractual documents that Mrs Dangarembga fully accepts and of which she leaves proof by signing hereby her agreement to each of them (Annex).

Second.- The obligations of Mrs. Dangarembga, listed in the technical specifications, mainly in clauses 2 and 3, are, among others, the following:

1st phase:

- Two online meetings to prepare the content and framework of the residency.

- Two advisory meetings for the CCCB teams, especially for the audiovisual production department.
- Public lecture at the CCCB in the framework of the Congress of Iberian Africanists, which will take place in Barcelona on 29, 30 and 31 January.
- Conceptualization of a cycle of public conversations around audiovisual creation made for women and the representation of female figures on the African continent.
- Proposal of possible lecturers, contact and confirmation of their participation.
- Writing the texts that describe and accompany the cycle. Writing and public reading of the inaugural conference and conducting of the two public conversations with the guests of the cycle, which will be part of a publication.
- Conceptualization of an interdisciplinary seminar on literary and audiovisual creation in Africa.

2nd phase:

- Inaugural press conference, interviews and first phase of meetings with the press (date pending).
- Conference for secondary school students within the framework of the "A morning with" program.
- Participation in the educational and community project "School in residence"
- In-depth interview for the development of teaching materials for the Open University of Catalonia (UOC)
- Interview for the audiovisual project "CCCB Interview".
- Working meetings with the Dones Visuals collective and the CCCB.
- Direction and participation in the interdisciplinary seminar "Blackness and women: creation in Africa".
- Public conference within the framework of the Congress of Iberian Africanists (January 29).
- Meetings with cultural agents of the city of Barcelona (date pending).
- Meeting with film students (date pending).
- Meeting with the association of film producers of Catalonia

3rd phase:

- Meeting with readers at the Finestres bookstore.
- Direction and conduct of public conversations with international guests within the framework of the cycle curated for the CCCB.
- Meetings with cultural agents of the city of Barcelona (date pending).
- Second phase of interviews and meetings with the press (date pending).
- Open Classroom for CCCB teams.

The contract includes also all necessary working meetings with the CCCB's project preparation team.

Third. - Accommodation

In order to carry out the advisory and curating work, subject of this contract, the CCCB will make available to the resident the dwelling located in Barcelona on [REDACTED] as described in the Technical Specifications Document attached to this contract.

Fourth. - The contract price is €19,500, VAT excluded.

The contractor will submit an invoice at the end of each of the phases of execution of the works established in the Technical Specifications Document that governs the contract.

Payment will be made by the CCCB, subject to prior consent from the Department of Mediation of the CCCB, within the time limits established in article 198.4 LCSP.

Public limited companies, limited liability companies and other entities included in article 4 of Law 25/2013, of December 27, on the promotion of electronic invoicing and the creation of the accounting register of invoices in the public sector, will have to submit electronic invoices in accordance with current regulations.

The following DIR3 codes must be included in all electronic invoices:

Accounting office (role 01) LA0006837

Managing body (role 02) LA0006837

Processing unit (role 03) LA0006837

Fifth. - The contract will be valid from the date of its formalization and until the completion of the contracted works, scheduled for April 13th, 2025.

Sixth. - The contractor agrees with the Specific Administrative Clauses Document that governs this contract, signing a copy of the same that is attached as an Annex, and submits, for everything that is not found in the aforementioned established document, to the pertinent rules of the contractual order in public administrations.

Seventh. - The parties undertake to treat, during and after the validity of this contract, all information known by virtue of its execution, as well as information provided to each other, in a strictly confidential manner, using it solely and exclusively for the purposes expressed in this contract, and adopting the necessary measures to prevent its knowledge by third parties.

Eighth. - All issues that may arise from the modification, termination, interpretation and compliance of this contract shall be resolved by the contracting body. The agreements may be appealed before the courts of Barcelona corresponding to the contentious-administrative jurisdiction, with express waiver by the contractor of any other jurisdiction or court that may correspond to it.

And for the record, the parties sign this contract, in Barcelona, on the date indicated in the respective digital signatures.
