CLAUSES

PRICE: USD 60,000 (sixty thousand USD) shall be paid free of deductions for all taxes, VAT, commissions, bank charges and exchange expenses of any kind.

PAYMENT SCHEDULE: 1st payment (USD 30.000) — due at the signing
2nd payment (USD 30.000) — due within a week after the event Talent Arena 2025.

MEDIA: Media interviews may be granted upon mutual agreement of the parties.

BRIEFING: Conference call/meeting between MWCcapital and Kasparov to be arranged if necessary at a mutually convenient time.

COPYRIGHT: Copyrights in any of the material or ideas used for or in connection with the lecture shall be and remain vested with Kasparov. MWCcapital will be entitled to record Kasparov's show and to integrate parts of Kasparov's show in a film concerning the event to be produced by the organizer. For clarity, such film or excerpts of the recording thereof, may be displayed on any media in connection with material relating to the lecture.

CONFIDENTIALITY: Both parties shall keep the terms of this agreement confidential, except as required by applicable law.

INDEPENDENT CONTRACTOR: For the purposes of this Agreement, the Parties are independent contractors, and nothing herein shall constitute an employer/employee relationship, partnership or joint venture between them.

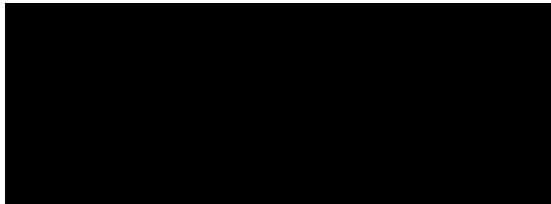
