Terms and Conditions

1. MathSciNet.

MathSciNet is the online version of the AMS publications *Mathematical Reviews*, from 1940 to present, and *Current Mathematical Publications*. The AMS reserves the right to add or delete MathSciNet content at any time.

2. Scope of License. Use Restrictions.

The license includes authorization of access by means of specific IP addresses of Consortium participants to allow site-wide online access by authorized users at Consortium participant sites via multiple connections. If a proxy server is being registered for access, the subscriber agrees to maintain the security of the access by authenticating authorized users before allowing use of the proxy to any remote or on-site user. "Authorized users" are employees, faculty, staff, or students officially affiliated with a participant of this Consortium, and authorized on-site patrons of a Consortium participant's library facilities. This license entitles the authorized users to access MathSciNet by multiple connections, to:

- a. make searches of MathSciNet;
- b. make one or more copies in hard copy form of the output of any search; such copies may not be sold and may not be distributed to anyone who is not an authorized user; and
- c. download search results to hard disk or diskette, provided that such data is not made available to anyone who is not an authorized user.

Authorized users who do download and/or print search results must maintain all copyright and other notices.

Downloading of substantial portions of the database is prohibited. Automated searching or downloading, by use of scripted searches, robots, spiders, crawlers, or otherwise, is also prohibited. However, all users may make use of free tools provided by the AMS for batch retrieval of information from the database provided such use is in compliance with copyright statements and terms of use posted from time to time on MathSciNet.

Copies of individual reviews from *Mathematical Reviews* may be made and delivered in the context of inter-library loan in compliance with Section 108 of the Copyright Act of the U.S. and within the CONTU guidelines.

An authorized user or Consortium participant may not make MathSciNet available to anyone other than another authorized user, whether by telephone link or by permitting access through his or her terminal or computer, or by other similar or dissimilar means or arrangements. Each Consortium participant will make reasonable efforts to maintain security and monitor all use (including unauthorized use) from its respective site and to communicate the terms of the license to their users.

Authorized users will be bound by the limitations stated in any copyright statement or terms of use posted from time to time on MathSciNet, except to the extent (if any) that such provisions may be inconsistent with the express terms of this license.

Requests for waivers of any of the restrictions stated or referred to above may be considered on a case-by-case basis and should be addressed to the Executive Editor of Mathematical Reviews, mrexec@ams.org.

3. Access.

MathSciNet access is granted site-wide only to those IP addresses specifically listed in this agreement (numeric IP domain addresses). Consortium participants may request access for any number of IP addresses; however, usage must be restricted to a single site.

This Agreement will become effective on its signing and shall cover the access starting with January 1, 2025 to December 31, 2027.

The annual Consortium Database Fee and annual MathSciNet subscription fee may be raised by written notice to the Consortium Contact, given at least three months prior to the next succeeding renewal date. The Consortium, on or before the renewal date, must pay the fees for each year that this Agreement is renewed or the renewal will be invalid. The AMS is not responsible for the collection of any fees owed by Consortium participants to the Consortium or any refunds owed by the Consortium to the Consortium participants.

Consortium requests are evaluated and priced individually. A new Consortium agreement is required to add Consortium participants. New Consortium participants may not be granted MathSciNet access without explicit approval from the AMS.

A Consortium participant may withdraw at any time from the Consortium provided written notice of such withdrawal is given to the AMS. Withdrawal during the subscription year (January through December) will not entitle the Consortium or the participant to any fee rebate from the AMS.

5. Support.

MathSciNet includes online documentation. In addition, the AMS will provide Consortium participants (and individuals at those sites) with e-mail and/or telephone support service during AMS's normal business hours (Monday-Friday, 9:00am to 4:00 pm, ET). The email address for support questions is msn-support@ams.org; the telephone number for support is 800-321-4267.

6. Copyright.

MathSciNet and its contents are subject to copyright, database protection, and other rights of the publisher (AMS), under the laws of the United States and the country of use.

Consortium participants acknowledge that they have no claim to ownership by reason of use of or access to MathSciNet.

7. Suspension or termination of access.

The AMS reserves the right to suspend and/or terminate access to MathSciNet for any Consortium participant without prior notice if a Consortium participant violates any term of this Agreement.

Any use of the MathSciNet database beyond the scope of the License or any fraudulent, abusive, or otherwise illegal activities may be grounds for termination of access.

8. Warranties, etc.

- a. The AMS has made and will make good faith efforts to ensure that MathSciNet is complete and accurate. However, the AMS does not warrant completeness or accuracy, and does not warrant that the Consortium participant's use of MathSciNet will be uninterrupted or error-free, or that the results obtained will be useful or will satisfy the user's requirements.
- b. The AMS warrants that it is entitled to grant the licenses outlined in this Agreement, but makes no other warranties or representations of any kind, expressed or implied, including but not limited to warranties of merchantability or fitness for a particular purpose.
- c. Consortium participants will be permitted to access MathSciNet at any time. The AMS will not be liable for any delay, down time, or other failure of performance, but will use reasonable efforts to correct any performance problem brought to its attention.
- d. The AMS will not be responsible for incidental, consequential, or any other damages arising out of or in connection with the service or materials provided hereunder.

- e. Each Consortium participant assumes the sole responsibility for all use of MathSciNet by their respective sites and users.

9. General.

- a. This Agreement together with Exhibit A, Acknowledgment of Consortium License Agreement Terms and Conditions, constitutes the entire agreement of the parties and supersedes any prior communication between the parties with respect to the subject matter hereof. Only a written instrument signed by both parties (AMS and the Consortium Contact) may amend it. Without limitation of the foregoing, any purchase order or other instrument that the Consortium may issue for MathSciNet is for the Consortium participant's internal purposes only and will in no way modify, add to or subtract from the terms and conditions provided herein.
- b. Neither the Consortium nor any of its participants may assign, transfer, or sublicense any rights under this Agreement.
- c. The benefits of this Agreement, including but not limited to MathSciNet access, will be available only to Consortium participants that have executed an Acknowledgement of Consortium Subscription Agreement Terms and Conditions in the form attached hereto as Exhibit A.

"GOVERNING LAW & DISPUTE RESOLUTION"

The parties agree to use best efforts to resolve disputes in an informal manner, by decision of the Managing Director of the Publisher and the current Chairman of the Consortium.
