

Call for tenders is hereby made for award through Open Procedure and ordinary processing contracting of the service of a comprehensive tool for genomic analysis and online interpretation of data derived from Whole Genome Sequencing (WGS), Whole Exome Sequencing (WES) and RNA sequencing (RNAseq) of tumor samples of pediatric patients and patient-derived xenograft (PDX) models by the projects:



2. Purpose of the contract:

- a) Purpose: The object of this tender procedure is service of Next generation sequencing service and data analysis and report including DNA and RNA sequencing from human tumour samples, paired with sequencing of peripheral blood samples as a control sample by the Project Pl23/01045 titled "Plataforma integrativa multiómica para la identificación de biomarcadores predictivos de respuesta a quimioterapia e inmunoterapia en cáncer de mama triple negativo temprano (PORTRAIT-TNBC)" of the Fundació Hospital Universitari Vall Hebron -Institut de Recerca (VHIR), funded by Instituto de Salud Carlos III (ISCIII) and cofunded by the European Union.
- b) Type: Service contract. CPV: 73111000-3







c) Division by lots and number: No. This tender is not divided into lots because it is related to only one service, which is the genomic analysis and online biological data interpretation of WGS, WES and RNAseq data from tumor samples of pediatric patients and PDX models. Although the data may originate from different sequencing techniques, the genomic analysis and interpretation must be carried out in an integrated manner. To ensure consistency and comparability across all data analyzed within the projects, this service must be conducted using the same comprehensive tool.

d) Place of execution:

Location: The bidder will have to provide the service object of this tender in its own facilities, which must have the technology and personeel necessary.

- Work time: The schedule will be determined by the center where the service is provided.
- e) Duration: The duration of the service object of this tender will coincide with the validity of the aforementioned projects which is, overall, until 31 December 2027.

The service will start on the day following the formalization of the contract.
