PURPOSE: The purpose of this call for tenders are the technical and support services for approval of auditors to delivery certificates on the financial statements prepared for European Projects be contracted by the post award unit at the Competitive Research Directorate or by the Research Groups of the Fundació Hospital Universitari Vall d'Hebron - Institut de Recerca (VHIR) which might require their services.

This tender is distributed by the following lots:

- Lot 1: Preparation and delivery of the Certificate on the Financial Statement (CFS) in accordance with the requirements set by the European Commission or other relevant funding agencies.
- Lot 2: Advisory and consultancy services on the implementation of Actions, with a specific focus on audits, checks and/or reviews done by the European or any other Granting Authorities, as well as on any related matters not explicitly covered by the rules for participation in grants.
- BASE TENDER BUDGET: EIGHTY-FOUR THOUSAND SEVEN HUNDRED EUROS (€ 84.700,00), VAT included. The total maximum budget is divided as follows:
  - Lot 1: The maximum total budget, corresponding to the initial two years, is set to SIXTY THOUSAND EUROS (60.000,00 €), VAT not included.
  - Lot 2: The maximum total budget, corresponding to the initial two years, is set to TEN THOUSAND EURO (10.000,00€), VAT not included.
- ESTIMATED CONTRACT VALUE: ONE HUNDRED EIGHTY-NINE THOUSAND EUROS (€ 189.000,00) VAT not included. broken down as follows:
  - Budget (tax base) (without VAT) Lot 1: 60.000,00 Euros
  - Budget (tax base) (without VAT) Lot 2: 10.000,00 Euros
  - Possible amendments Lot 1: 12.000,00 Euros
