SECOND - TO ACCEPT THE PROPOSAL OF AWARD made by the Contracting Committee on 29th of September of 2025.

THIRD - TO REQUIRE under Article 150. 2 of Law 9/2017, of November 8, on Public Sector Contracts, to the company **Hartwig Medical Foundation (NL855072490B01)**, for being the company that has formulated the proposal with the best value for money in accordance with the award criteria provided in the Specific Administrative Clauses Tender Specifications, so that, within 10 working days from the day following the day on which it receives notification of this requirement, it may present the documentation required in **Clauses 6 and 12** of the Specific Administrative Clauses Tender Specifications:

- Documentation relating to the proof that the company is validly constituted and that, in accordance with its corporate purpose, it may bid for the bid. Also, deeds of representation of the person signing the bid. The presentation of the certificate of registration in the ROLECE or RELI issued by the corresponding organism is also accepted.
- Documentation accrediting that it complies with the economic, financial and technical or professional solvency required in the Particular Administrative Clauses. The presentation of the certificate of registration in the ROLECE or RELI issued by the corresponding organism is also accepted.
- Certificate of being up to date with Social Security (Seguridad Social). The presentation of the certificate of registration in the ROLECE or RELI issued by the corresponding organism is also accepted.
- Certificate of being up to date with the tax authorities (Agencia Tributaria). The presentation of the certificate of registration in the ROLECE or RELI issued by the corresponding organism is also accepted.
- Positive certificate issued by the Generalitat de Catalunya accrediting the non-existence of tax debts with the mentioned administration. The presentation of the certificate of registration in the ROLECE or RELI issued by the corresponding organism is also accepted.
- To have contracted a civil liability insurance policy with a sufficient amount to cover liabilities of any kind that may arise from the execution of the contract.
- Proof of constitution of the definitive guarantee corresponding to 5% of the amount of the award, excluding VAT, which is **€ 8.550,00**.
- We detail Article 108 of the LCSP, in accordance with the provisions of Clause 15 of the Administrative Clauses that regulate this bidding process:

Artículo 108. Garantías definitivas admisibles.
