On 02nd October of 2025, the contracting body of the la Fundació Hospital Universitari Vall Hebron – Institut de Recerca (VHIR) requested to the company Hartwig Medical Foundation with NIF number NL855072490B01 the necessary documentation in order to raise the award of the contract of service of Next generation sequencing service and data analysis and report including DNA and RNA sequencing from human tumour samples, paired with sequencing of peripheral blood samples as a control sample by the Project PI23/01045 titled “*Plataforma integrativa multiómica para la identificación de biomarcadores predictivos de respuesta a quimioterapia e inmunoterapia en cáncer de mama triple negativo temprano (PORTRAIT-TNBC)*” of the Fundació Hospital Universitari Vall Hebron - Institut de Recerca (VHIR), funded by Instituto de Salud Carlos III (ISCIII) and co-funded by the European Union. That likewise, the proposed company has accompanied within the deadline all the documentation required

for this purpose on 13th October of 2025, with the exception of the certificate from Caixa General de Dipòsits.

On 3rd November of 2025, the contracting body of the la Fundació Hospital Universitari Vall Hebron – Institut de Recerca (VHIR) requested the bidding company to submit the certificate from Caixa General de Dipòsits within three working days.

RESOLVED,

First.- To elevate the award of the contract related to the service of Next generation sequencing service and data analysis and report including DNA and RNA sequencing from human tumour samples, paired with sequencing of peripheral blood samples as a control sample by the Project PI23/01045 titled “*Plataforma integrativa multiòmica para la identificación de biomarcadores predictivos de respuesta a quimioterapia e inmunoterapia en cáncer de mama triple negativo temprano (PORTRAIT-TNBC)*” of the Fundació Hospital Universitari Vall Hebron - Institut de Recerca (VHIR), funded by Instituto de Salud Carlos III (ISCIII) and co-funded by the European Union, to the following company:

 - 2.920,00 euros (VAT excluded) Unit price for sequencing and data analysis of tumor genomic DNA and normal blood DNA (reference DNA), including extraction, sequencing, data analysis and reporting of the results in a manner valid for routine diagnostic purposes.
 - 500,00 euros (excluding VAT) Unit price for RNA sequencing and reporting from the same piece of tumoral tissue
- c) Other criteria offered:
 - Quality control of the samples by shallow sequencing before full whole genome sequencing.
 - Allow small batches of samples (minimum of 2 samples per batch) to be sent.
 - Turn-around-time of results 15 days or shorter from the reception of the samples.

Second.- To notify this award to the beneficiaries of the same as well as to the other bidding companies participating in the bidding procedure.
